<p><b>Indemnity:</b> Each user of a Site, as a part of its use of a Site and as a condition to the right to use of the Site, shall indemnify and hold harmless the Village of Mattawan, as well as its officials, agents, and employees from and against any and all claims, damages, causes of action or costs, of any kind or nature arising out of the use of a Site as provided for in this policy. Nothing in this policy shall be interpreted or treated as a waiver or release by the Village of any defenses or immunities to which it is otherwise entitled by law.</p> <p><b>Clean Up/Damages:</b> Please be respectful of Village parks and facilities. All users are required to clean up the Site as good as or better than when they found it. Users shall bag all trash, rubbish, and pet wastes resulting from their use and shall place it in trash receptacles. If receptacles are full or non-existent, the bagged refuse shall be hauled away by user. Non-compliance with this provision may result in loss of deposit and in the user being billed for the expenses the Village incurs for such clean up/damages.</p> <p>I have read, understand and will comply with and agree to be bound by the restrictions and conditions stated in the attached and incorporated Village of Mattawan's Recreation Area Ordinance including, without limitation, all indemnification provisions.          _____ (Applicant's initials)</p> <p>I understand and agree that I am fully responsible for all activity conducted at the above facility on the day, date, and times stated.
